Motion was made by Keith Harrison to invite Baird Equity Asset Management & Westfield Capital Management Company, LP to present to the Board about their Mid Cap Growth equity strategy, and to invite Nuance Investments and MFS Investment Management to present on their Mid Cap Value equity strategies.
